Plaintiffs Adam Steele, Brittany Montrois, and Joseph Henchman, on behalf of themselves and the Class, hereby submit this Status Report Regarding Notice to the Class, informing the Court of the procedures undertaken by the Claims Administrator to execute the Court's approved notice plan.

On September 9, 2016, this Court issued its Order Approving Plan of Class Notice, which provided the notice plan and established that "[t]he opt-out period shall expire on December 7, 2016." ECF No. 68, at 2. The Declaration of Kathleen Wyatt Regarding Notice Procedures ("Wyatt Decl."), attached hereto as Exhibit 1, summarizes the steps taken by the Claims Administrator to comply with the Order, including the following:

- Obtaining a list of 1,227,683 name and address records on August 23, 2016
 (Wyatt Decl. ¶ 2);
- 2. Causing the approved Email Notice to be emailed to 1,222,165 potential class members on October 7, 2016 (*Id.* ¶ 3);
- 3. Creating, before October 7, 2016, a case-dedicated website for the matter (www.PTINClassAction.com), providing access to the long-form notice, relevant court

documents, important dates, answers to frequently asked questions, and contact information for

the Claims Administrator and Class Counsel (*Id.* \P 4);

4. Creating, before October 7, 2016, a toll-free telephone number with recorded

information and answers to frequently asked questions (*Id.* \P 5);

5. Causing, on October 21, 2016, the approved Postcard Notice to be mailed to

150,351 potential class members without valid email addresses whose addresses were confirmed

with the National Change of Address (*Id.* $\P\P$ 7–8); and

6. Remailing 11,050 of the 15,248 Postcard Notices returned as undeliverable after

updating addresses with a skip trace vendor (*Id.* \P 9).

As a result of these steps, the Claims Administrator received 1,064 timely requests from

potential class members for exclusion from the class, as well as eleven late requests. *Id.* ¶ 10.

Those eleven late requests were accepted by this Court in its January 25, 2017 Order Accepting

Untimely Opt-Out Requests. ECF No. 76.
